

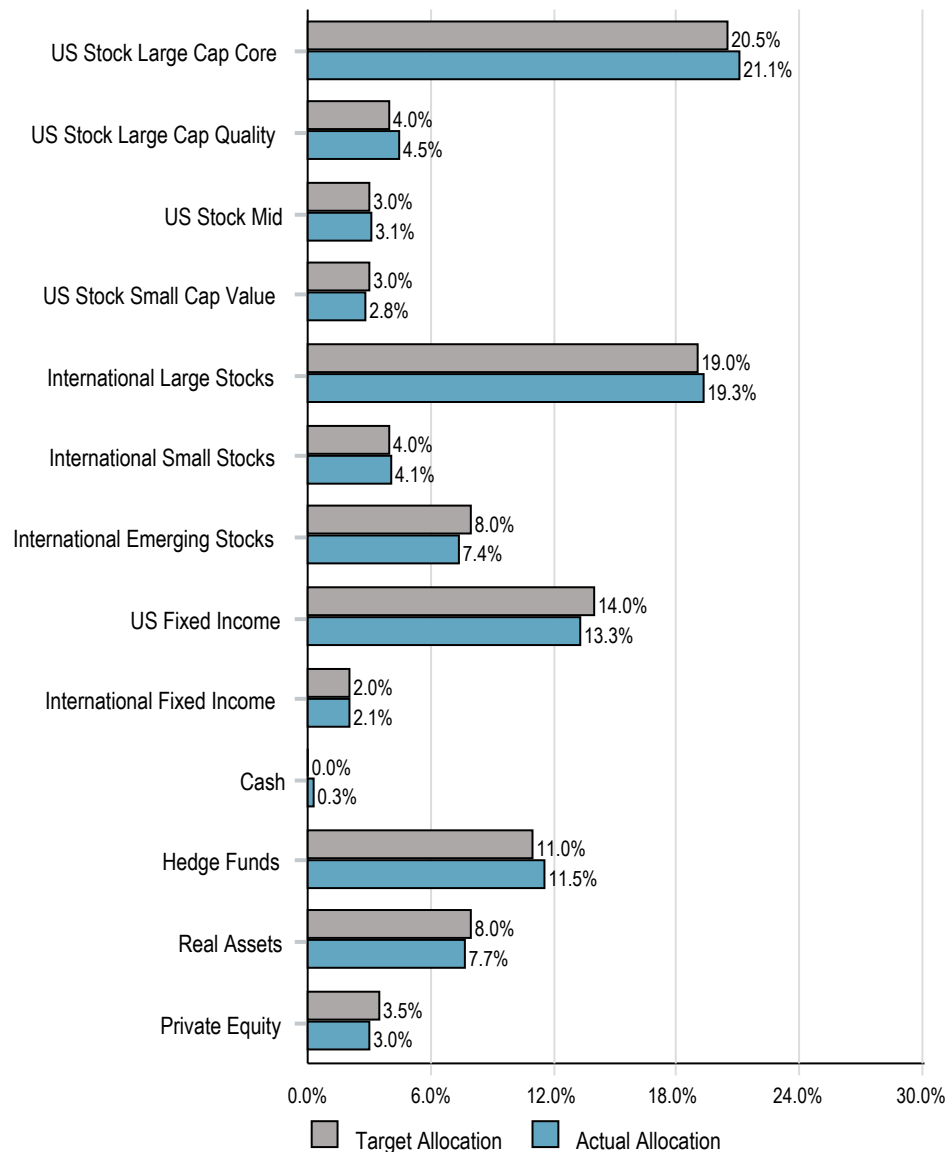

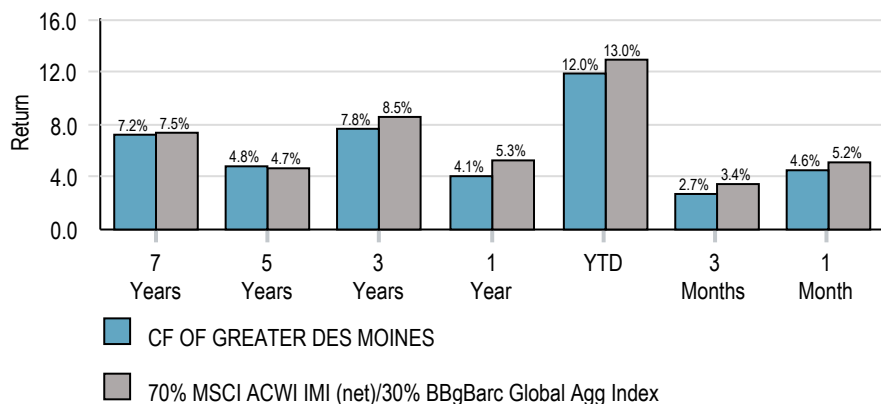
Target Allocation vs. Actual Allocation (%)

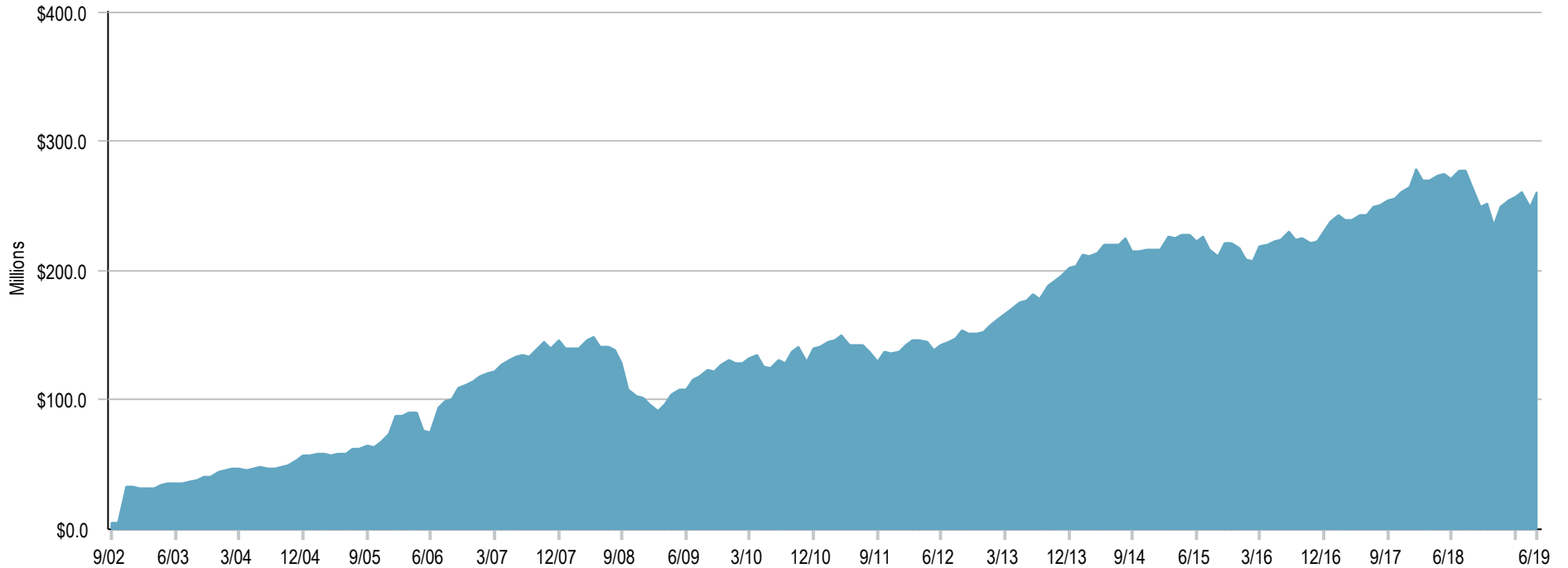
